Collective conversations: The Influencers Meet

The members of the Influencers group met once again on June 20, 2019 at Edelweiss House for a half-day meeting which covered the importance of re-scripting the theory of violence against women (women against violence), discussed the power of target groups demanding and driving the social change they wish to see (Right to Pee movement) and demonstrated how each one with an intent and willingness to do what they can with resources at hand can shift the needle in favour of the disempowered (The Sankalp experiment).

He juxtaposes the urgency to revive the process of legal reform in human trafficking, by highlighting cases of women, children and men having been rescued from bonded labour and sexual exploitation in Tamil Nadu, Uttar Pradesh and Delhi.

In lieu of completing 24 years, **ANANDI** held a national round table conference on June 18 and 19, 2019 discussing the vulnerability of girls and young women on account of discriminatory values, law and customary practices in the backdrop of revisiting the **Beijing Platform Action Goals**. Agency, choice and consent were emphasised upon and discussed at great length by means of interactive sessions. Identification of opportunities and challenges in addressing the needs of girls and young women by maximum utilisation of the existing State programs and services such as Childline, *Sabla*, etc made the discussion more fruitful.

VACHA facilitated and hosted the 'Leaders for Change Summit 2019, organised by Shadhika where 36 young girls engaged with four civil society organisations from different geographies such as Delhi, Bangalore, West Bengal and Mumbai stayed together to experience the amalgamation of learning, knowledge sharing, ideas and creativity. These girls were chosen based on their leadership showcased towards social initiatives in their respective communities and the Summit was aimed to enhance these skills further through activities ranging from intense sessions around social issues to fun filled games for women and using comics as a means of engagement. The end of the four-day initiative had a graduation ceremony for the girls to commemorate their achievement. It formed a cherished memory and an experience of a lifetime for these young girls.
